Reacting to the death of soldiers in an encounter with terrorists in the Doda district of Jammu and Kashmir, he told reporters, "India will give a befitting reply to Pa-



kistan-sponsored terrorism. Peace has been restored in Jammu and Kashmir and it is our responsibility to maintain it. We will counter every conspiracy of Pakistan."Four army personnel, including an officer, died after being injured in a gunfight with heavily armed terrorists in Doda district, officials said on Tuesday. Sarma is scheduled to visit Torpa and Khunti assembly constituencies on Tuesday and participate in workers'

felicitation programmes and Vijay Sankalp Sabhas. "The BJP will form a double-engine government again in Jharkhand by uprooting the current dispensation," he told reporters after arriving at Ranchi's Birsa Munda

Airport. On Wednesday, he will address party workers as part of a Vijay Sankalp Sabha at BJP headquarters in Ranchi.The state BJP has been organising assembly-wise worker felicitation programmes and Vijay Sankalp Sabhas from July 6 to celebrate the success of the recently concluded Lok Sabha polls.The BJP won eight Lok Sabha seats, while its ally AJSU Party won one in the state which has 14 Lok Sabha seats. # Calcutta HC restrains Mamata Banerjee from making derogatory remarks against Governor CV Ananda Bose

Kolkata: The Calcutta High Court on Tuesday, July 16, issued an interim order preventing West Bengal Chief Minister Mamata Banerjee from making derogatory statements about Governor CV Ananda Bose. Justice Krishna Rao passed the order, and the matter is scheduled for further hearing on August 14. Governor Bose has filed a defamation suit against CM Banerjee and three others following her statements concerning allegations of sexual harassment made by a female staff member of the West Bengal Raj Bhawan against the Governor. The court emphasized that the Governor, being a



"Constitutional Authority," should not be subjected to personal attacks through social media platforms by the Chief Minister.

The court's order stated, "This court is of the view that in appropriate cases where the statements have been made in a reckless manner to cause injury to the reputation of the plaintiff, the court would be justified in granting an injunction. If at this stage, an interim order is not granted, it would give the defendants free hands to continue making defamatory statements against the plaintiff and continue to tarnish the reputation of the plaintiff." The Calcutta High Court on Tuesday, July 16, issued an interim order preventing West Bengal Chief Minister Mamata Banerjee from making derogatory statements about Governor CV Ananda Bose.

The court also noted that without an interim order, the Governor CV Ananda Bose would "suffer irreparable loss and injury to his reputation." Consequently, the defendants are restrained from making any defamatory or incorrect statements against the Governor through publications or social media platforms until August 14.

#### Supreme Court issues notice on pleas to transfer NEET cases from High Court to top court

New Delhi: The Supreme Court has issued a notice on NTA's petitions to transfer NEET-UG 2024 exam cases from the Rajasthan High Court. This comes amidst allegations of paper leakage and malpractices in the exam. The Supreme Court, on July 15 issued a notice on petitions filed by the National Testing Agency (NTA) on the transfer of NEET-UG 2024 exam cases pending before the Rajasthan High Court to the apex court.A bench consisting of Chief Justice DY Chandrachud and Justices JB Pardiwala and Manoj Misra cited a similar plea which the NTA had filed earlier, stating that the apex court had already stayed proceedings before High Courts. The Court ordered, "Issue notice and tag," as per media reports. The Supreme Court is seized of a batch of petitions seeking direction to recall NEET-UG 2024 results and to conduct the examination afresh, alleging paper leakage and



malpractices in the test held. Earlier, aspirants had approached the top court and raised the issue of leakage of question paper, awarding compensatory marks and anomaly in the question of NEET-UG. The Supreme Court, on June 11 ordered the agency to respond to some petitions but refused to halt counselling for admissions of students to medical colleges. Meanwhile, on July 8, the Court said that it would have to determine to what extent the exam was compromised to decide whether a retest would be needed or not.

### Pathsala Municipality faces corruption allegations over failed water supply schemes

Guwahati: In a troubling display of alleged corruption within the Pathsala municipality, residents are raising alarms over the mismanagement and degradation of vital water supply schemes in religious areas. Approximately Rs 20 lakhs were allocated for the construction of a pure drinking water supply system in the Harimandir and Bhagwati areas. However, just a year and a half after their installation, the water pipes and basins have fallen into a state of disrepair, rendering the schemes almost non-functional. "In 2022, in Pathsala, such 8 water supply project was set up. This entire project cost approximately Rs 10 lakh.



Two such projects were set up here in Hari Mandir and at Bhagawati. The work started in 2022 and was completed in 2023. Public even started receiving water from this project. But for the past one year, the supply has stopped. Also, it has been alleged that very poor quality of materials

have been used in the project", said Jiten Talukdar, secretary of Pathsala Bazaar Committee. The situation is particularly dire in the Bhagwati region, where the annual Rasa Mahotsav is being held amidst the deteriorating infrastructure. The contractor responsible for these projects, Hamidur

Rahman of Jorhat, is under scrutiny for the poor qualitv of work delivered. This pattern of mismanagement and corruption is reportedly endemic within the Pathshala municipality, overseen by BJP leader and corporator Jolly Chaudhary, who has been frequently accused of corrupt practices. The installation of substandard pipes and motors has been a common issue, exacerbating the failure of these schemes. Despite residents informing the municipality of these issues a month ago, there has been no action taken. The municipal council has seemingly turned a blind eye to the complaints, further fueling public outrage.

# Supreme court seeks government response on Nagaland's petition



Kohima: The Supreme Court has asked the Union Government to respond to a writ petition by Nagaland challenging the denial of prosecution of 30 Indian Army personnel. The case relates to the killing of 13 civilians in Mon district during a military operation in 2021. The Supreme Court has issued a notice to the Union Government regarding a writ petition filed by the state of Nagaland. The petition challenges the Centre's refusal to sanction the prosecution of 30 Indian Army personnel accused of killing 13 civilians during a military operation in Mon district in December 2021. A bench led by Chief Justice of India DY Chandrachud, along with Justices

JB Pardiwala and Manoj Misra, has given the Ministry of Defence six weeks to respond to the notice.

Nagaland's Advocate General KN Balagopal argued that despite evidence gathered by the state police against the accused army men, the Centre denied prosecution sanction under the Armed Forces Special Powers Act (AFS-PA) 1958 on February 28. The incident in question occurred on December 4, 2021, when army personnel allegedly fired at a pickup truck carrying miners in Oting village, Eastern Nagaland. This led to the filing of FIRs under various sections of the Indian Penal Code. The case has reignited debates about AFSPA in the Northeast. Following the incident, the Nagaland Assembly unanimously called for the repeal of AFSPA from the North East, particularly from Nagaland.

Nagaland's Advocate General KN Balagopal argued that despite evidence gathered by the state police against the accused army men, the Centre denied prosecution sanction under the Armed Forces Special Powers Act (AFSPA) 1958 on February 28. This legal challenge by the Nagaland government brings the controversial AFSPA back into national focus, highlighting tensions between state autonomy, military operations, and civilian protection in conflict-prone regions.

# Suryakumar Yadav emerges as dark horse for T20I captaincy

New Delhi: The big-hitting Survakumar Yadav has emerged as the dark horse to become India's T20 captain till the 2026 World Cup and might just pip top contender Hardik Pandya, whose elevation from the vice-captain's position was being seen as a natural progression up until now. Pandya made himself available for the shortest format games against Sri Lanka this month but it has emerged that Suryakumar, who captained India in eight T20Is against Australia and South Africa last year, is the preferred choice of new head coach Gautam Gambhir and chairman of selectors Ajit Agarkar. It is learnt that both Gambhir and Agarkar spoke to Pandya about this change of plan earlier this evening and explained to him that a long-term option was being finalised to ensure stability. The T20 leadership role fell vacant after Rohit Sharma bid adjeu to his international career in the shortest format following India's World Cup triumph last month in the West Indies. Pandya, one of the heroes of that victory, will take a break during the three-match ODI series against the island nation due to "personal reasons". The T20Is against Sri Lanka will run from July 27 to 30 in Pallekele, followed by the ODIs from August 2 to 7 in Colombo.



The squad for the series is expected to be announced in the next couple of days. "Hardik Pandya was India's T2O vice-captain under Rohit Sharma. He is completely fit and available for the three-match T2OI series and was supposed to lead the side but there is a very strong feeling that SKY would be the potential leader not only for the Sri Lanka series but till the 2026 World Cup," a senior BCCI source said on conditions of anonymity. "Hardik's break from ODIs is for very personal reasons. He doesn't have any fitness issue as is being suggested in the media," the official said. T h e 3 3 - y e a r - o I d Suryakumar is believed to be one of the most popular players in the Indian dressing room. It was under Gambhir's captaincy at the Kolkata Knight Riders that he made a name for himself as a T20 player and got nicknamed 'SKY' by the then skipper. Hardik was seen as an obvious successor to Rohit but multiple factors have come into play. His performance as Mumbai Indians skipper was underwhelming and the selectors are in no mood to let him pick and choose his assignments.

# Mani to captain 18-member India 'A' squad

New Delhi Off-spin all-rounder Minnu Mani has been named captain of the 18-member India 'A' women's squad set to tour Australia for a multi-format series starting from August 7. They will then play three 50-over matches at Mackay on August 14, 16 and 18 respectively, followed by a four-day match against Australia A at Gold Coast from August 22-25. The squad also includes capped India players Priya Punia, Shubha Satheesh, Kiran Navgire, Sajana Sajeevan, Uma Chetry, Saika Ishaque, Mannat Kashyap and Meghna Singh. Batter Shweta Sehrawat and left-arm spinner Tanuja Kanwar, who are amongst traveling reserves for the upcoming Women's Asia Cup, are also included



in the squad, with the former named as vice-captain. Shabnam Shakeel (subject to fitness) and S. Yashasri, who were Shweta's teammates in the 2023 U19 Women's T20 World Cup triumph in South Africa, have been included too, so as notable domestic performers Tejal Hasabnis, Shipra Giri, Raghavi Bisht, Priya Mishra and Sayali Satghare. Pacer Saima Thakor, who turned out for UP Warriorz in WPL 2024, has been named as a stand-by player. # 10 days to Olympics 2024: Tracking India's top 10 medal hopes in Paris

**NEW DELHI:** The Olympic Games Paris 2024 are just 10 days away, and India's elite athletes are in their final leg of preparation In our final tracker ahead of the Olympics. ESPN takes a look at how the preparations are going for India's top 10 medal prospects: Neeraj Chopra: defending Olympic The champion hasn't competed since winning the Paavo Nurmi Games last month, as he prioritises fitness over competitions. Like a few athletes on this list, he's currently in training at Saarbrucken, Germany. Vinesh Phogat: Vinesh won the Grand Prix of Spain last week defeating Mariia Tiumerekova 10-5 in the final. Competing in the unfamiliar 50kg category in which she won the Olympic quota, Vinesh looked comfortable through the tournament. Vinesh will see this as a confidence-boosting performance as she continues her search She now remains in Madrid where she will be training ahead of the Olympics. PV Sindhu: Sindhu, looking for a historic third-straight Olympic medal, is currently training in Saarbrucken, Germany with coach Agus Dwi Santoso and team. She also now has learnt of her draw at the Olympics. In the group stage, she has a pretty easy (by her standards) start as she's set to face Estonia's Kristin Kuuba (world no 75) and Maldives' Fathimath Nabaaha Abdul Razzaq (world no 111). Win the group and she will most likely find herself facing China's He Bing Jiao (world no 8). Win that and there's a potential quarterfinal with defending Olympic champion Chen Yu Fei (world no 2) in store. Satwiksairaj Rankireddy and Chirag Shetty: The doubles pair, fondly known as Sat-Chi, haven't competed on the BWF tour since May 28, where they lost in the opening round in the Singapore Open. Despite that ignominious finish and injury concerns ahead of the Olympics, Sat-Chi have been in decent form during the year and remain amongst the favourites in Paris. After a bit of a wait, they learnt of their

Olympic draw on Monday: the third seeds are grouped with Indonesia's reigning All England Champions Faiar Alfian and Mohammad Ardianto (world no 6), Germanv's Mark Lamsfuss and Marvin Seidel (world no 31) plus France's Lucas Corvee and Ronan Labar (world no. 43). Their path through the knockouts (top two go through) is unclear since the men's doubles matches in the KOs are to be set after another draw. Aditi Ashok: Competing in the Amundi Evian Championship (in HauteSavoie, France), Aditi had her (joint) best finish of the calendar year 2024 with a tied-17th place finish. in three of four since June she has averaged below 70. Men's hockey team: After a brief camp in Bengaluru, the men's hockey team went to Switzerland for a team bonding exercise and are currently training in the Netherlands. They will be landing in Paris on the 20th In their last bit of competitive action. Craig Fulton's men didn't have a great run in the Europe leg of the Pro League: results that saw them finish seventh, only above Spain and Ireland. Nikhat Zareen Having won her last competition (the Elorda Cup) in May, two-time (and reigning) world champion Nikhat Zareen will go into Paris with her confidence high. She, along with five other boxers are amid a month-long training at the Olympic Centre in Saarbrucken, Germany. She will then travel to Paris on July 22.

Most recently seen in action at the Munich World Cup, she won bronze in her 50m rifle 3 positions event, missing silver by just 0.1 point to China's Han Jiayu. Mirabai Chanu: Olympic silver medalist Mirabai Chanu is in her final leg of training, and has reached France (Le Ferte-Milon, a northern region) as she acclimatizes to the country. Having struggled with injuries for most of the last year, Mirabai will be looking to continue on her path of full recovery. Her target, she says, is to lift 90kg in snatch and 115kg in the clean and ierk.
