# India, Pakistan war of words over Shehbaz Sharif raking up Kashmir issue at UN

Exercising its right of reply, India sharply criticised Shehbaz Sharif's address at the UN General Assembly

New Delhi: Hours after Pakistan Prime Minister Shehbaz Sharif brought up the Kashmir issue at the United Nations General Assembly, India hit out at the speech, saying that Islamabad's continued support for cross-border terrorism will "inevitably invite consequences".

Exercising its Right to Reply in the UNGA, First Secretary in India's Permanent Mission to the UN Bhavika Mangalanandan stated: "This assembly regrettably witnessed a travesty this morning. A country run by the military, with a global reputation for terrorism, narcotics, trade and transnational crime has had the audacity to attack the world's largest democracy. I speak about the reference to India in the speech of the Pakistani PM. As the world knows, Pakistan has long employed cross-border terrorism as a weapon against its neighbours. It has attacked our parliament, our financial capital, Mumbai,





marketplaces and pilgrimage routes. The list is long..." "For such a country to speak about violence anywhere is hypocrisy at its worst. It is even more extraordinary for a country with a history of rigged elections to talk about political choices that, too, in a democracy," she added.

The envoy also went onto remind Pakistan about the "genocide it committed in

1971". "The world can see for itself what Pakistan really is. We are talking about a nation that for long hosted Osama bin Laden. A country whose fingerprints are on so many terrorist incidents across the world, whose policies attract the dregs of many societies to make it their home," she added. The statement came after Pakistan Prime Minister Shehbaz Sharif

alleged that India has resiled from its commitments to implement the UNSC resolutions on Jammu and Kashmir.

In his speech, Sharif alleged: "Like the people of Palestine, the people of Jammu and Kashmir too have struggled for a century for their freedom and right to self-determination. Instead of moving towards peace, India has resiled

plement the Security Council resolutions on Jammu and Kashmir. These resolutions mandate a plebiscite to enable the people of Jammu and Kashmir to exercise their fundamental right to self-determination." Since 5th August, 2019, India has initiated unilateral illegal to impose what its leaders call a final solution to Jammu and Kashmir. Day in and day out, 900,000 Indian troops terrorise the people of occupied Jammu and Kashmir with draconian measures including long curfews, extrajudicial killings, and the abduction of thousands of voung Kashmiris. ■ Dhaka: Radical Islamic groups in Bangladesh have threatened the minority Hindus not to openly celebrate Durga Puja in the country and are against nationwide holidays during the festival. They also asked the Hindus not to protest against them.

## ED likely to book K'taka CM in MUDA case

Bengaluru: The En-Directorate forcement (ED) is likely to register a case of money laundering against Karnataka CM Siddaramaiah and his wife, among others, in connection with the MUDA case, it is learnt. Sources said an Enforcement Case Information Report (ECIR) may be registered by the end of the day or by tomorrow, based on an FIR registered by the Karnataka Lokayukta.

"We are in possession of the details of the FIR and relevant case details. The offences fall under the schedule of the Prevention of Money Laundering Act (PMLA). A case will be registered soon after completing necessary formalities," a senior ED official



said.

Registration of an ED case could open the doors for attachment of properties belonging to the CM and his family, apart from more coercive measures. Earlier this year, two sitting CMs - Jharkhand CM Hemant Soren and Delhi CM Arvind Kejriwal - were arrested in connection with cases filed by the ED. Both were recently granted bail after several months behind bars.

### Case against Nirmala Sitharaman over 'extortion' through electoral bonds

Bengaluru: A Bengaluru court has ordered the registration of an FIR against Union Finance Minister Nirmala Sitharaman over allegations of extortion through the now-scrapped electoral bonds.

A complaint against Nirmala Sitharaman and others was filed by one Adarsh lyer from the Janaadhikara Sangharsha Sanghatane, alleging that extortion was carried out through electoral bonds.

Following this, the Special Court for People's Representatives in Bengaluru has ordered an FIR to be filed in the matter. Police have registered the FIR against Nirmala Sitharaman and others. In February, the Supreme Court scrapped the electoral



bonds scheme, calling it "unconstitutional" and saying it violated citizens' right to information. The Centre introduced the scheme in 2018 and was aimed to replace cash donations to political parties, seeking to improve transparency in political funding. Reacting to the case, Karnataka Chief Minister Siddaramaiah demanded Nirmala Sitharaman's resignation

and said a report in the matter should be submitted within three months.

"An FIR has been registered against Nirmala Sitharaman in the Special Court for People's Representatives. Who is she? She is a Union Minister, and there is an FIR against her too. They were involved in extortion through electoral bonds and the FIR has been registered on that.

# Govinda accidentally shoots himself

■ Mumbai: Actor and Shiv Sena leader Govinda was hospitalized in Mumbai on Tuesday after accidentally shooting himself in the leg with his licensed revolver. The bullet has been removed, and Govinda's condition is stable, according to his manager. The incident occurred at 4:45 a.m.

# Meghalaya ranks third lowest-performing state in urban governance



Shillong: Meghalaya has been ranked as the third lowest-performing state in urban governance after Nagaland and Manipur, according to a new national study. Shillong was previously identified as a low-performing city in the smart city project.

The study has been conducted by the Praja Foundation and the National Institute of Urban Affairs The research-(NIUA) ers conducted extensive fieldwork, visiting 43 cities across 28 states and three union territories and engaging with 2,213 key stakeholders. including representatives, administrators, academics, members of civil society, among others.

The findings, released on Thursday, revealed that Shillong falls short in several key areas, including empowered city representatives, administration, citizens, and fiscal empowerment

The Urban Governance Index evaluates the effectiveness of urban governance based on four key factors: elected representatives, administration, citizens, and finances. The Praja Foundation, which is a Mumbai-based non-profit organization, and NIUA released the Urban Governance Index 2024, ranking cities and states and identifying their shortcomings in civic governance.

Kerala emerged as the top-performing state in urban governance, followed by Odisha, Maharashtra, Chhattisgarh, and Madhya Pradesh. Meanwhile, Nagaland, Manipur, and Meghalaya were ranked as the lowest-performing states.

#### BJP Manipur Pradesh pleads for release of abducted youths amid rising tensions

Imphal: The BJP Manipur Pradesh has issued an urgent appeal for the safe release of two abducted Oinam Thoithoi and Thokchom Thoithoiba. The young men reportedly took a wrong turn while travelling on September 27, leading to their capture. The political party is calling for their release on humanitarian grounds. Chief Minister N Biren Singh, on September 29 convened emergency meeting with MLAs from all parties to address the crisis. The abduction, allegedly carried out by suspected Kuki militants, has sparked outrage across the state. A disturbing video surfaced on social media showing

the captive youths pleading for help from Chief Minister Singh. The victims urged the government to treat them "as sons" and meet the kidnappers' demands, heightening public concern. The abduction occurred when three youths went missing on September 27 while travelling to New Keithelmanbi for an SSC GD recruitment test. One of the missing individuals, Ningombam Johnson Singh, was rescued by Army personnel and returned to his family. The BJP Manipur Pradesh expressed gratitude to those involved in securing his release. CM Singh emphasised the importance of political unity in tackling the crisis.

#### Assam and Meghalaya to continue border talks in October

Guwahati: Meghalaya Chief Minister Conrad Sangma announced today that the ongoing border negotiations between Assam and Meghalaya are set to continue, with the next round of talks anticipated in October. This decision comes as both states work towards resolving complex disputes that have persisted over the years.

In a media briefing, Sangma emphasized the importance of ongoing dialogue, stating, "We have been having regular official meetings. Personally, I have also had discussions with Dr. Himanta Biswa Sarma ji. We have decided that we will continue the dialogue now and meet. Other areas are complicated, so we will have to ensure to discuss everything in minute details.... Most likely, we should be able to meet in October."

## Tripura government signs Rs 692 crore MoU to boost tourism

Saha highlighted the tourism industry s one of the key sectors driving economic growth in the country and state

Agartala: The Tripura government has signed a Memorandum of Understanding (MoU) worth Rs 692 crore to enhance tourism infrastructure in the state with the construction of ropeways. This was announced by Chief Minister Manik Saha on the occasion of World Tourism Day 2024.

Saha said that the proiect aims to improve connectivity and boost tourism in the region. The MoU was signed between the Tripura Tourism Development Corporation Limited and National Highways Logistics Management Limited. The project involves the construction of ropeways connecting key tourist sites such as Udaipur Railway Station to Matabari, Maharani to Chabimura, Surmachara,



and Jampui Hills. High-lighting the importance of tourism, the Chief Minister said that tourism is an important sector for the economic growth in the state also as well as in the country. He emphasized the state's rich natural and cultural heritage, with significant religious tourism destinations including Tripura Sundari Temple, Kasba Kalibari, Fourteenth Goddess Temple, Mangal-

chandi Temple in Amarpur, and Mahamuni Pagoda.

Additionally, the state government is working on enhancing key sites like Matabari in Udaipur and making Narkelkunja and Dumbur more appealing to tourists.

CM Saha further added that the state is building up its tourism infrastructure through various programmes initiated by the centre

## Indian Army sets up high-altitude artillery firing range in Arunachal Pradesh

Itanagar: The Indian Army has set up a new artillery firing range in Arunachal Pradesh's Tawang sector, making it the first in a high-altitude area. Arunachal Pradesh falls under the Eastern Command of the Indian Army.

The new artillery firing range has helped the Army to practice the firing of howitzers and other important weapon systems. Director General of Artillerv. Lt Gen Adosh Kumar. at a media briefing in New Delhi, said, "A new firing range has been set up in the Tawang sector where we can fire our howitzers and test their capabilities. This is the first high-altitude range and we are trying to find more ranges in other states.'

He said that activating this range in the northern border would give the artillery "a sense of actual operational environment. Lt Gen Kumar said that in the past two years, the Army has identified two firing ranges in Arunachal Pradesh. While the one



in Tawang has been operationalised, the other is in the process of getting notified, he added. Given the ongoing standoff with China along the Line of Actual Control (LAC), the new firing range in Arunachal Pradesh is strategically significant.

The officer said, "Our modernisation and capability development plan align with the 'Atmanirbharta' drive and is based on the principle of modernisation through indigenisation." The Army is looking at increasing the range of high explosive pre-fragmented (HEPF) shells by a range of 15-20 percent. Lt Gen Kumar said while trials were over,

the contract was in the final stages and would likely be signed in this financial year. The Army is also engaged in procuring loiter munitions, swarm drones as well as runway independent remotely-piloted aircraft systems, or RPAS. Several 155 mm calibre guns or howitzers have been inducted in the Regiment of Artillery and these include ultra-light Howitzer (ULH), K-9 Vajra, Dhanush and Sharang.

ULH have been inducted along the northern borders, Lt Gen Kumar said. They are lighter in weight and can be carried underslung by helicopters. K-9 Vajra Gun System is ideal for mechanised operations.

# AFSPA extended in Manipur by 6 more months

Imphal: The Manipur government on Monday extended the Armed Forces (Special Powers) Act (AFSPA) by another six months in the state, excluding 19 police station areas falling under the Imphal valley and a region that shares its boundary with Assam. "The state government is of the opinion after analysing the prevailing law and order situation in the state that it is not expedient to have a detailed assessment on the ground as security agencies are preoccupied with maintenance of law and order." the notification said.

"The governor of Manipur hereby accords approval to declare the entire state of Manipur excluding the areas falling under the jurisdiction of 19 police stations... as Disturbed Area for a period of six months with effect from 1st October," the notification signed by Commissioner (Home) N Ashok Kumar.

### Sensex plunges 1,600 points, investors lose 8 lakh crore today



Mumbai: Benchmark equity indices opened lower today (October 3) as Sensex dropped 1,600 points and the Nifty50 slipped below the 25,300 mark at a time when other Asian markets also witnessed decline owing amid the escalating Middle East conflict. Investors across the globe are on tenterhooks as tensions in Middle East intensified after Iran fired ballistic missiles at Israel earlier this week. Twelve of the 13 major sectoral indexes logged losses, with realty and auto indexes set to be top losers by percentage, dropping about 2.6% and 1.7%, respectively. Among individual stocks, consumer goods firm Dabur

lost 5.5% after forecasting its first quarterly revenue decline since 2020. Most brokerage stocks, such as Motilal Oswal Financial Services and 5Paisa Capital, fell about 1.5% each, while SMC Global lost about 2.3%, days after India's markets regulator SEBI tightened rules for equity derivatives trading. "Investors are worried about the Middle East conflict right now as it will have a huge bearing on Indian markets since any rise in oil prices will have an adverse impact on the country, which is an importer of the commodity," Raghvendra Nath, managing director at Ladderup Wealth Management, said.

### RBI's new MPC members may have least one favouring rate cut

Mumbai: India's newly-appointed monetary policy committee members may see at least one dissenter calling for a rate cut when the group meets next week, several economists said in separate research notes this week.

India's government on Tuesday appointed Ram Singh, Saugata Bhattacharya and Nagesh Kumar as new external members of the Reserve Bank of India's rate-setting panel. The reshuffle could change a recent split view within the six-member panel, where



two external members voted for a rate cut in August on the argument that high inflation adjusted real rates could hurt growth. The doves' departure reduces chance of a

cut next week, Shilan Shah of Capital Economics said in a note. Though 80 per cent of the economists polled by Reuters expect a status quo in the RBI's October policy,

calls for a cut or at least a change in stance have grown since the US Federal Reserve began its rate cut-

ting cycle last month. "We expect the MPC to keep policy rates and stance unchanged next week, with at least one dissenting vote, likely from the new external members," Barclays economists Shreya Sodhani and Amruta Ghare said. Several economists pointed to an opinion piece written by Bhattacharva in mid-August where he was in favour of rate cuts, suggesting he could be the dissenter.



# Sensex crashes 1,700 points as Middle East crisis triggers bloodbath on D-Street

**Mumbai:** As the Iran-Israel conflict continues to escalate, the domestic stock market is feeling the heat, with the Sensex plunging over 1,400 points.

The sharp decline has raised alarm bells among investors, prompting concerns about the potential ripple effects on the Indian economy.

The Sensex was down 1,737.30 points, trading at 82,528.99 at around 1:47 pm, while the NSE Nifty50 tumbled 530.70 points to 25,266.20. The total market capitalisation of BSE-listed companies witnessed a staggering decline of approximately Rs 8 lakh crore. At the heart of this market turmoil is the



surge in oil prices triggered by escalating tensions in the region. Iran's missile strikes on Israel have stoked fears of disruptions to global oil supply, pushing Brent crude prices beyond \$75 per barrel and West Texas Intermediate to approximately \$72. For oil-importing nations like India, these price hikes could lead to increased inflationary pressures, impacting everything from transportation costs to corporate earnings.

Trivesh D, COO, Tradejini, highlighted that rising oil prices could add pressure on India's fiscal deficit, forcing the government to reallocate funds from key infrastructure or public wel-

fare projects to cover the higher costs. Dr. VK Vijayakumar, Chief Investment Strategist at Geojit Financial Services, said, "If Israel retaliates by targeting Iranian oil installations, we could see an unprecedented spike in crude prices, which would be particularly damaging for India's economy." Market experts are advocating for a cautious approach during this period of heightened uncertainty. Vijayakumar suggests that investors diversify their portfolios into defensive sectors like pharmaceuticals and fast-moving consumer goods (FMCG), which tend to be less volatile during geopolitical cri-

### Is flavoured yoghurt good for health?

oghurt has long enjoyed a reputation as a healthy food staple-loaded with probiotics, calcium, and protein. But before you start spooning it up guilt-free, it's worth asking: Is it really as healthy as it is considered to be?

#### The health halo of yoghurt

#### How is yoghurt different from curd?

Deepali Sharma, clinical nutritionist at the CK Birla Hospital, Delhi, explains, "Yoghurt and curd differ in their bacterial strains, fat content, and texture. Yoghurt is made using specific bacteria like lactobacillus bulgaricus, which is beneficial for gut health. It's often made with low-fat or skimmed milk, resulting in a thicker and creamier consistency. Curd, on the other hand, is traditionally made from whole milk using natural lactic acid bacteria, which gives it a

The hidden sugar trap While yoghurt may seem like a healthy choice, one of the biggest issues is hidden sugar That 'low-fat vanilla yoghurt' you think is a smart option could actually have as much, if not more, sugar than a small cup of ice cream. Brands often add sugar to low-fat yoghurts to enhance flavour, turning what seems like a wholesome snack into a sugary indulgence that could spike your blood sugar levels. To see which is healthier, we compared Epigamia blueberry yoghurt (85 gm) and Amul strawberry ice cream (100 gm). The ice cream had a larger portion size and significantly more calories (219 kcal) compared to the yoghurt (78 kcal). While yoghurt offered more protein (5.2 gm vs. 3.7 gm), the ice cream contained more sugar (16 gm vs. 11 gm) and much higher fat content (13 gm vs. 1.6 gm). Both products provided calcium, but the ice cream had slightly more (170 mg) compared to the yoghurt (143 mg). While flavoured yoghurt is healthier due to lower fat and higher protein content, it's important to remember that the added sugars (7 gm) still make it a sweet treat. As dietician Sharma advises, "Flavoured yoghurts can have calorie counts similar to ice cream, especially with added sugars. Opting for unsweetened, low-fat ones is a smarter, healthier choice."
