## **Uniform Civil Code draft**

Gandhinagar: The BJP government in Gujarat announced the formation of a committee, headed by a retired Supreme Court judge, to frame guidelines for implementing the Uniform Civil Code (UCC).

The five-member committee, to be headed by former Supreme Court judge Ranjana Desai, will submit its report within 45 days, Gujarat Chief Minister Bhupendra Patel said on Tuesday.

"To assess the need for a Uniform Civil Code (UCC) and to prepare a draft bill for the same, we have decided to form a committee under the former judge of the Supreme Court," he said. Other members of the panel include retired IAS



officer CL Meena, advocate RC Kodekar, educationist Daxesh Thakar and social worker Gita Shroff.

Guiarat Home Minister Harsh Sanghavi said that all aspects will be considered in preparing the report. "The Chief Minister has directed this committee to do detailed research on it in the next 45 days and present a report to the government," he said. The state government will take a decision about the implementation of the UCC after receiving the report, he added.

## Gujarat govt forms panel for | SC seeks reply from Centre on NEET-PG plea

■Blocking seats caused meritorious candidates to lose their seats: The Plea

New Delhi: The Supreme Court on Tuesday sought replies from the Centre. National Medical Commission (NMC), and others on a plea filed by a batch of students seeking fresh counselling of all India quota (AIQ) round 3 of NEET-PG 2024.

A two-judge bench of Justices B R Gavai and K Vinod Chandran issued notices to UOL NMC. and others, sought their respective replies, and posted the matter for further hearing on February 7. The petitioners, eligible for NEET-PG 2024 counselling, said round 3 of AIQ counselling for NEET-PG started before the second round could conclude in certain states The plea



said that when round 2 counselling opened, they had the option to choose between the best options and leave the AIQ seat if they were getting a better seat in the next round of counselling.

"This created a grave prejudice to the petitioners and similarly placed candidates since they were deprived of the seats which were blocked by the candidates from the states whose round 2 did not commence earlier," the plea said.

The petitioners alleged that the respondents' act was inconsistent with the schedule of NEET-PG counselling laid down by the apex court.

#### Tejashwi seeks Governor's intervention in Bihar law, order



Patna: Leader of opposition in Bihar assembly Teiashwi Prasad Yadav on . Wednesday met Governor Arif Mohammad Khan at Raj Bhavan and handed over a memorandum seeking his intervention in the state's deteriorating law and order situation.

The meeting has created ripples in political circles as the budget session of the Bihar legislature is expected to begin on February 28. During a brief meeting with Governor, Tejashwi expressed his deep concern over frequent incidents of murder, loot, indiscriminate firing and rape.

"There is anarchy in the state. Criminals are operating under the tutelage of ruling dispensation, which is a matter of grave concern. People belonging to minority communities are being targeted on one pretext or the other. The chief minister is little concerned about such happenings," he alleged. Tejashwi shared information about his meeting with the Governor on social media 'X' explaining that the memorandum contained the problems of the people across the state during the present dispen-

## Government raises tax exemption to ₹12 lakh, easing middle class burden

New Delhi: Finance Minister Nirmala Sitharaman on Saturday gave the middle class and the common man enough reasons to smile when she announced her personal income tax pro-

Not only did she increase the income threshold up to which no taxes would be levied from Rs 7 lakh to Rs 12 lakh, she also changed the income tax slabs that will lead to a substantial reduction in tax burden for all taxpayers under the new tax regime. With these changes, and the standard deduction of Rs 75,000, an individual earning Rs 12.75 lakh a year will have to pay no taxes under the new tax regime.

However, if one's taxable income crosses that threshold, all the income would be taxed as per the new slabs, which are both magnanimous and generous.

The new tax slab increases the basic exemption limit from Rs 3 lakh to Rs 4 lakh, which means the first Rs 4 lakh would attract no taxes. Income from Rs 4-8 lakh would attract a rate of 5%, Rs 8-12 lakh would attract 10%

From Rs 12,00,001 to Rs



16 lakh, there will be 15% tax and from Rs 16,00,001 to Rs 20 lakh, the tax rate would be 20%. The government has introduced a new tax slab of 25%, which would be applicable on income from Rs 20,00,001 to Rs 24 lakh. The highest tax slab of 30% kicks in only if the income crosses Rs 24 lakh per annum.

A taxpayer in the new regime with Rs 12 lakh income will save Rs 80,000 in tax (which is 100% of tax payable as per existing rates). A person earning Rs 18 lakh will get a tax benefit of Rs 70,000 (30% of tax payable as per existing rates), while a person with an income of Rs 25 lakh gets a benefit of Rs 1,10,000 (25% tax payable as per existing rates). Meanwhile, the FM also announced that the new direct tax bill will be

#### Congress to decide on joining Omar Abdullah govt in J&K

Party ties joining cabinet to J&K statehood restoration

Srinagar: With uncertainty looming large on Congress's alliance with ruling National Conference in Jammu Kashmir, the party high command would take a call on the party joining the Omar Abdullah-led government. At present, J&K has six cabinet ministers including Chief Minister Omar Abdullah.

Since J&K's Legislative Assembly strength is 90, there can only be nine ministers in the elected government in the Union Territory. Three cabinet berths are lying vacant in the Omar government and there are expectations that before the Budget session, the CM may go for expansion of the cabinet and fill



all three vacant posts. At present J&K does not have a Finance Minister and CM Omar is himself looking after the ministry.

It remains to be seen whether the CM leaves one or two cabinet berths for its pre-poll ally, Congress. The Congress, which had contested the Assembly polls in alliance with Congress and won five seats, decided against joining the Omar government when the CM and five cabinet ministers took oath on October 16.

## 'We are three-member body, not run by one person': EC hits back at AAP

New Delhi: Amid allegations levelled by the Aam Aadmi Party that the Election Commission is being run by CEC Rajiv Kumar, the poll panel on Tuesday hit back saying it is a three-member body which has collectively noted "repeated deliberate pressure tactics" to malign the poll authority in Delhi polls. It



said an impression is being created that the EC is a single member body. In a post on X, the EC said it has decided to have constitutional restraint, absorbing such outbursts with sagacity, stoically and not to be swayed by such insinuations.

Top AAP leaders, including its convenor Arvind Karjiwal, have claimed that the EC has been ignoring the BJP's alleged violations of poll code. Kejriwal claims Kumar avoids action against BJP for post-retirement assignment

# VPP accuses Congress leader of exploiting religion for political gain

Shillong: The Voice of the People Party (VPP) has hit back at Meghalaya Congress leader Ronnie V Lyngdoh, accusing him of repeatedly bringing religion into politics. VPP spokesperson Batskhem Myrboh claimed that Lyngdoh is "playing the religious card" in his own constituency, Mylliem.

Myrboh's remarks came in response to Lyngdoh's accusations that the VPP was using religion in politics. The VPP spokesperson denied these alle-



gations, suggesting that Lyngdoh's own actions were motivated by a desire to exploit religious sentiments for political gain.

In a separate allegation, Lyngdoh had claimed that VPP's Mylliem candidate, Aibandaplin Lyngdoh Nonglait, had misled voters by falsely claiming to have completed her education in Theology during the 2023 Assembly election.Myrboh dismissed this claim, pointing out that Nonglait had not mentioned the qualification in her affidavit, but this did not necessarily mean she was lying. The VPP has challenged Lyngdoh to conduct his own investigation into the matter, saying, "Let Ronnie conduct his private investigation and complete whatever process he deems neces-

#### Centre passes buck on illegal rat-hole mining to Assam govt

New Delhi: The Union Minister of State for Environment and Forest, Kirti Vardhan Singh, admitted in Lok Sabha that rat-hole mining is illegal and falls under the purview of the state government The Minister's response came on Monday to questions raised by Congress MP Pradyut Bordoloi and other members regarding the government's efforts to combat this illegal practice.

Minister Singh acknowledged that rat-hole mining, a dangerous and environmentally destructive practice, is illegal and falls under the purview of the state administration. He detailed actions taken following an incident near the Dehing Patkai National Park (then wildlife sanctuary) in Assam's Tinsukia district, including a suo motu case by the National Green Tribunal (NGT). The tribunal's judgment directed the Tinsukia Deputy Commissioner to secure the mines and prevent further rat-hole mining.

He mentioned that the North Eastern Coal Field Limited (NECL) has been tasked with guarding the area, and the Assam government has implemented measures like drone surveillance, restrictions under Section 144 CrPC, eviction operations, and joint patrolling. He outlined efforts to rehabilitate areas with safe drinking water, river treatment, afforestation, and alternative livelihood projects.

# Manipur Governor launches anti-addiction campaign

Imphal: Launching the 'Addiction Free Manipur Campaign,' Governor of Manipur, Ajay Kumar Bhalla has called upon the people particularly the youth, to come together to combat the menace of drugs and contribute towards achieving a developed India (Viksit Bharat) by 2047.

At a glittering function held at the Raj Bhavan in Imphal on Monday, the campaign is being organized by Brahma Kumaris in collaboration with the Ministry of Social Justice and Empowerment, Government of India under Nasha Mukt Bharat Abhiyan (NMBA) – a flagship program of the Ministry.

The campaign aims to tackle the problem of substance abuse across the state through awareness generation, mass mobilization, and community outreach targeting vulnerable groups and the general masses. Officially, there are around 1.5 lakh drug addicts in Manipur.

# Separate electoral roll for non-tribals in GHADC deemed "legally untenable"

Shillong: A recent demand by the Sarvadaliya Sammelan, a minority body, for a separate electoral roll for non-tribals in the Garo Hills Autonomous District Council (GHADC), Meghalaya has been met with strong opposition.

Social activist Cherian Momin termed the demand as a blatant attempt to subvert the constitutional safeguards provided under the Sixth Schedule of the Constitution towards the Scheduled Tribes.

Momin stated that the GHADC is a constitutionally mandated autonomous institution, established to ensure self-governance and self-determination for the indigenous Garo people. He added that any effort to restructure its electoral framework in favour of



non-tribals would be an assault on the constitutional sovereignty of Scheduled Tribes. The exclusion of non-tribals from the electoral rolls of GHADC, Momin pointed out, is not an act of discrimination but a protective mechanism to prevent the political marginalization of indigenous communities. He urged constitutional authorities, policymakers, and the judiciary to prevent any move that threatens the sanctity of the Sixth

Schedule, Momin also dismissed the argument that non-tribal settlers should be granted electoral rights or be territorially excluded from GHADC, citing that their continued residence in these areas does not grant them the constitutional right to political representation within a tribal self-governing body. The demand for non-tribal representation, Momin said, is a direct attack on the foundational principles of tribal.

## Assam University staffer held for alleged minor molestation

Silchar: A 57-year-old non-teaching employ-ee of Assam University in Silchar was arrested on Sunday following accusations of molesting a 14-year-old girl on the university campus. According to police, the alleged incident occurred on Friday morning.

The victim, who had accompanied a relative working as a university cleaner to the campus, was waiting outside an empty classroom in the law department when the accused allegedly forced her inside and attempted to sexually assault her.

Other staff members and students intervened and rescued the girl. The victim's family stated that she had been at Assam University with the relative on Thursday night.



The relative, required to report for duty on Friday morning, asked the girl to wait at the university while he worked.

Police have identified the accused as Faruque Ahmed. A First Information Report (FIR) has been filed at the Dwarbond police station under the Protection of Children from Sexual Offences (POCSO) Act and the Bharatiya Nyaya Sanhita (BNS). Cachar Superintendent of Police (SP) Numal Mahatta confirmed the arrest and filing of charges. Police said that the girl has been sent to a shelter home.

#### **RBI** begins rate talks, 25-bps cut expected

Mumbai: Days after the Union Budget, the Reserve Bank of India (RBI) on Wednesday started deliberations on the monetary policy amid expectations of a 25 basis-points rate cut, which will be the first in five years, as inflation remains within central bank's comfort zone, though the sliding rupee continues to be a concern.

RBI last cut rates by 40 bps to 4% in May 2020 during the Covid crisis. But in May 2022 the central bank started a rate hike cycle in view of the Russia-Ukraine war and paused it only in May 2023. New RBI Governor Sanjay Malhotra to chair his first MPC meeting from



## Northeast sees surge in Oesophageal cancer, calls grow for advanced medical investments

Guwahati: The rising incidence of oesophageal cancer in Northeast India is fueling demand for advanced medical technologies and investment in specialized healthcare. According to a recent Indian Council of Medical Research (ICMR) report, tobacco consumption-48.2% among adults in the region compared to the national average of 29%-is a key driver behind this alarming trend. Assam is at the epicenter of the crisis, with Dibrugarh reporting the highest proportion of cases at 15.7% (1 in 54 males), followed by Kamrup Urban at 14.3% (1 in 27 males) and Cachar

at 11.6% (1 in 53 males).

Due to the limited availability of high-end medical facilities, patients from the Northeast often seek treatment in other parts of the country. Leading oncologists, including Dr. Surender Kumar Dabas and Dr. Bikram Kumar Deka, emphasize the need for investments in robotic-assisted surgery. Dr. Deka, Consultant - Surgical Oncology & Robotic Surgery at Max Hospitals, highlighted the gaps in medical infrastructure. "Key diagnostic tools like PET scans remain inaccessible in many areas, and robotic-assisted surgery is un-



derutilized," he noted. Dr. Dabas, Vice Chairman & HOD - Surgical Oncology at Max Hospitals, advocates for adopting minimally invasive surgical techniques to enhance patient outcomes.

"Traditional oesophageal surgeries carry high risks. Robotic-assisted dures improve precision,

reduce complications, and ensure faster recovery, allowing quicker access to follow-up treatments like chemotherapy and radiohe explained. therapy," Guwahati, as the region's primary healthcare and business hub, is witnessing a shift in healthcare investments.

Private hospitals are exploring partnerships to introduce advanced cantreatment facilities, including robotic-assisted surgeries. With rising demand, stakeholders are pushing for strategic investments to curb medical outflow and enhance local healthcare infrastructure.

## Sensex rises 1.8 per cent as trade tension eases

Mumbai: Domestic equity market surged on Tuesday as global trade tensions eased after US President-Former President Donald Trump postponed new tariffs on goods from Mexico and Canada by one month. Additionally, the planned 10% levy on Chinese exports to the US did not take effect as scheduled on Tuesday.

Following these positive global cues, the Indian equity benchmarks - BSE Sensex and NSE Nifty rallied up to nearly 2% on Tuesday. After hitting an intraday high of 78,658.59, the 30-share index Sensex settled at 78,583.81, up 1,397.07 points or 1.81%



while the Nifty50 ended at 23,739.25, up 387.20 points or 1.62%. The index traded in the range of 23,762.75 to 23,423.15 on Tuesday.

Investors' wealth rose by Rs 5.89 lakh crore to Rs 425.40 lakh crore (BSE m-cap) on Tuesday compared to Rs 419.54 lakh crore recorded on Monday.

Index heavyweight HDFC Bank and Reliance Industries gained between 2.5-

# **SEBI** announces



new 'algo

Mumbai: The Securities and Exchange Board of India (SEBI) has mandated stock exchanges to empanel algorithmic trading providers and has also defined rules for using application programming interfaces (APIs), according to a Business Standard report.

Algorithmic trading, also known as algo trading, is a method of executing trading orders by providing a predefined set of rules to a computer program.

This helps in placing share orders at a speed and frequency not possible for human traders.

Algo trading is already prevalent in India among both institutional as well as retail investors. However. existing regulations had several loopholes, posing risks to investors, according to a Business Standard report.

As a result, The Brokers' Industry Standards Forum will formulate algo trading standards before April 1, 2025, and they will become effective from August 1.

The new guardrails will be implemented through the exchanges. This also includes criteria for empanelment

Brokers will thus, only be able to onboard algo trading providers that are empaneled with the exchanges. Apart from this, they also have to obtain exchange approval, address grievances and even monitor prohibited activities.

## Swiggy Q3 results: Net loss widens to Rs 799 crore, GOV grows 38%



Bangalore: Food and grocery delivery firm Swiggy on Wednesday said its gross order value (GOV) grew 38 per cent year-onyear to Rs 12,165 crore. The company reported results today for the quarter and nine months ended December 31, 2024.

The consolidated adjusted Ebitda loss reduced by 2 per cent Y-o-Y to Rs 490 crore but rose Rs 149 crore quarter-on-quarter (Q-o-Q). The platform's average MTU (monthly transacting users) increased 25.3 per cent Y-o-Y to reach 17.8 million, with nearly a third of all users utilising more than one service on the platform.

Sriharsha Majety, managing director and group chief executive officer, Swiggy, said it continued to focus on creating segmented offerings for the consumer during the festive quarter, which it believes will open up more consumption occasions.

In recent months, Majety said the firm introduced Bolt and Snacc (10-minute food delivery), expanded into new categories within quick-commerce, and plans to offer a greater assortment. The company also launched Swiggy Scenes, focused on restaurant event reservations, and introduced One BLCK, the premium tier of its Swiggy One subscription programme.

"We delivered higher Y-o-Y growth across all three of our primary businesses during Q3, which GOV accelerated B2C growth to 38 per cent Y-o-Y," said Majety.

### Gold demand rises 1% in 2024, economic uncertainty to provide support: WGC

New Delhi: Global gold demand including overthe-counter (OTC) trading rose by 1 per cent to a record high of 4,974.5 metric tonnes in 2024 as investment increased, the World Gold Council (WGC) said on Wednesday, adding that central banks sped up buying in the fourth quarter.

Spot gold prices rose by 27 per cent last year, the most since 2010, as investors chose the metal to hedge against global risks and as the US Federal Reserve slashed interest rates. Prices hit another alltime high on Tuesday, driven by safe-haven demand after China retaliated with tariffs on the United States in response to President



Donald Trump's trade lev-

Central banks, a major source of gold demand, bought more than 1,000 tonnes of the metal for the third year in a row in 2024. The National Bank of Poland was the largest such buyer, adding 90 tonnes to its reserves, the WGC, an industry body whose members are global gold miners, said in a quarterly report.

In the final quarter of 2024, when Trump won the US election, buying by central banks accelerated by 54 per cent year on year to 333 tonnes, the WGC calculated, based on reported purchases and an estimate of unreported buying.

## **Atlantia Electricals files IPO papers** with Sebi, aims to raise Rs 400 cr

Mumbai: Atlanta Electricals Ltd, manufacturer of power, auto and inverter duty transformers, has filed preliminary papers with capital markets regulator Sebi seeking its approval to raise funds through an initial public offering (IPO).

The Gujarat-based company's IPO is a combination of a fresh issue of equity shares worth Rs 400 crore and an offer for sale (OFS) of 38.1 lakh equity shares by a promoter and other selling shareholders, according to the draft red herring prospectus (DRHP) filed on Tuesday. The offer includes a reservation of equity shares for subscription by eligible employees.

Besides, the company may consider raising Rs 80



crore in a pre-IPO placement round. If such placement is undertaken, the size of the fresh issue will be reduced

The company proposes to utilize the proceeds from the issue for payment of debt, supporting working capital requirements of the company and for general corporate purposes.According to a Crisil report, India's

transformer market is driven by the relentless growth in electricity demand, with per capita consumption surging by over 50 per cent in the last decade. Also, the government is investing in the renewable energy sector and expanding the power transmission network, which will create opportunities for the transformer market's growth.

#### RBI meeting kicks off; markets await rate decision

Mumbai: The Reserve Bank of India's (RBI) Monetary Policy Committee (MPC) meeting begins on Wedneday under the leadership of newly appointed Governor Sanjay Malhotra. This will be the first policy meeting of Sanjay Malhotra as RBI Governor.

Analysts are divided on whether the RBI will cut the repo rate for the first time in nearly two years or maintain the current rate to manage inflation and currency stability.

The six-member committee will announce its decision on February 7, 2025. Experts believe the RBI may reduce the repo rate by 25 basis points (bps) to support economic growth, especially after the Union Budget 2025 focused on boosting demand.

The repo rate has been 6.5% unchanged at



February and the last rate cut was announced during the Covid-19 pandemic in May 2020.

adan Sabnavis, Chief Economist at Bank of Baroda, believes economic conditions are suitable for a rate cut. "The budget has provided a growth stimulus, and inflation is expected to ease.

However, the rupee remains under pressure due to global trade uncertainties," he said. While some believe a rate cut is likely, others feel the RBI may wait for global economic conditions to stabilise before making any changes.

## Two in a row: India U19 World Champions, again



Chennai: WHFN Sanika Chalke heaved Monalisa Legodi past the square-leg fielder, the Indian dug out broke out with the loudest cheer at the Bavuemas Oval, Kuala Lumpur on Sunday evening. The moment the ball touched the ropes, players ran in with flag in hand to hug and celebrate with Chalke and G Trisha in the middle.

Defending champions India had beaten South Africa by nine wickets to win the 2025 ICC Women's U19 T20 World Cup. For a bunch of teenagers who have been together several months in their pursuit of one goal, it was a moment of jubilation. Some of them could barely hold their emotions together while a few were overwhelmed with happiness. And behind

every player is a story of sacrifice, heartbreaks and tireless hard work in getting to this point.

G Kamalini, the 17-yearkeeper-batter from Tamil Nadu, yelled in Tamil "Cup ah thookitom (We have lifted the trophy)," in delight. Six years ago, she hadn't picked up a cricket bat. She bowled for the first time while her father Gunalan was training her brother during lockdown. It was then Gunalan and Saranya saw a dream. They shifted from a tier two town of Madurai to Chennai for Kamalini's cricket and has been with her in every step of the way. "Cannot express our happiness. For all the struggles went through, this feels like god's gift. She is our gift," an emotional Gunalan told this daily.

London: Arsenal beat Manchester City 5-1 to keep their Premier League title hopes alive on Sunday, while Manchester United slumped to another meek 2-0 home defeat to Crystal Palace.

In the battle between the sides that have finished in the top for the past two seasons, the Gunners prevailed to move within six points of leaders Liverpool, who have a game in hand.

Arsenal were gifted the

perfect start inside two minutes as Manuel Akanji lost possession and Kai Havertz squared for Martin Odegaard to open the scoring. Havertz exposed Arsenal's lack of a clinical goalscorer when he wasted a glorious chance to double the lead.

#### All-round Abhishek seals 4-1 win for India


Mumbai: Abhishek Sharma lit up the Wankhede Stadium with boundaries as India beat England by 150 runs in the fifth and final T20I to win the series 4-1. The Punjab batter smashed his second T20I century, this time 135 runs from 54 balls, before taking 2/3 as England were bundled out for 97 in the chase

Opting to field first, England were welcomed with a six off the very first ball as Saniu Samson pulled Jofra Archer into the stands. The short-ball ploy against Samson had worked so far, but this time the India opener was keen to take them on. He went on to hit another six and a four in the same over before falling to Mark Wood.

That, however, in no way affected India as Abhishek went berserk. The southpaw hit 13 sixes and seven boundaries on his way to a 54-ball 135 while the others tried to keep up with him. Tilak Varma (24) and Shivam Dube (30) chipped as India finished with 247/9 in 20 overs.

In response, England lost Ben Duckett early to Mohammed Shami. But as it has been the case, spinners led to the visitors downfall. Ravi Bishnoi (1/9) and Varun Chakravarthy (2/25) set the ball rolling before Abhishek piled on. Dube also took a couple of wickets before Shami came back to finish things of.

The veteran pacer has blown hot and cold since his comeback and will take a lot of confidence from the 3/25 show against England in Mumbai on Sunday. He will be the key focus in the three-match ODI series between the two teams that begins in Nagpur on Thurs-



#### Gambhir lauds Abhishek's T20 century and India's fearless play

Mumbai: India head coach Gautam Gambhir on Sunday said he has not seen a "better T20 hundred" than Abhisek Sharma's 54-ball 135 against England here and asserted that the team will continue to play in a "fearless" manner going forward. Abhishek's brutal century was the cornerstone of India's heavy 150run win over England here, which also helped India bag the T20I series 4-1.

"We are going to do this going forward, got to play fearless cricket. We want to keep backing players like Abhishek Sharma. We have to be patient to with these boys. Most of these boys believe in the ideology of playing fearless cricket, Gambhir told host broadcaster after the match. "I haven't seen a better T20 hundred (Abhishek's ton)



against bowlers who are bowling at 140-150 kph consistently," he added.

There were talks about rift in Indian dressing room after the team's disastrous outing in the Border-Gavaskar Trophy series against Australia. Gambhir said everything will fall in place once the team returns to the winning ways. "They (these players) have played a lot of cricket against each other. That's all Indian cricket is all about us. "When results start going your way, everything goes well. Our players know what it means to represent 140-150 crore Indians," he added.

#### India look for balance against **England in last** CT

Nagpur: Form and fitness of seasoned stars is under the scanner as India enter the final phase of their Champions Trophy preparations with the threematch ODI series against England starting here on Thursday, aiming to find the right balance for some specific slots in the line-up. The likes of skipper Rohit Sharma and Virat Kohli have been under tremendous scrutiny after their dismal run in red-ball cricket.

The two stars, after making hyped but disappointing appearances in Ranji Trophy last month, will be eyeing strong performances in a format that they have dominated for several years. They were the top two run-getters of the 2023 World Cup with Kohli scoring 765 and Rohit smashing 597.

### Gill seeks ODI rebound against **England**

Nagpur: From the time the Border-Gavaskar Trophy came to an end, one of the debates about the Indian team was how long before Yashasvi Jaiswal made the ODI team.

While it did not take long. as the youngster was included in the squad for the England ODIs and Champions Trophy, he is still a standby. For, India have their captain Rohit Sharma and vice-captain Shubman Gill at the top. Although there is no one questioning Rohit's place in the ODI team at this point, Gill has come under the lens. Gill's poor form sparks calls for Jaiswal to replace him.

## Berrettini stuns Shimabukuro in Chennai Open

Chennai: Italy's Jacopo Berrettini, the younger brother of former Wimbledon finalist Matteo Berrettini, caused the first big upset in the main draw of the Chennai Open ATP Challenger with a straight sets win over sixth seed Sho Shimabukuro.

Berrettini, ranked No. 324 in the world won 6-3, 7-6



against Shimabukuro. In the other main draw match held fifth seed Shintaro Mochizuki of Japan defeated Italy's Enrico Dalla Valle 6-2, 6-1 to move into the

last 16.

Meanwhile, the four Indians in action on Monday failed to win their final round in the qualifying draw against higher-ranked opposition. In the qualifying draw, all four Indians who won their matches on Sunday failed to repeat their success in the final round of qualifying. 21-year-old

Chirag Duhan battled hard before falling in a third set tiebreak to seventh seed Yurii Dzhavakian 4-6, 6-1, 7-6. Dev Javia also went to three sets against Egor Agafonov before going down 4-6, 7-5, 6-3. Coppejans, Barton, Vanshelboim, and Zhukov joined Dzhavakian and Agafonov as qualifiers for the main draw.
